1. Schedule A – Sewer and Water Usage

Water Rate \$7.61 / 1000 gallons

Wysox Bulk Sewer Rate \$5.59/ 1000 gallons

3. Schedule C – Fire Protection

\$100.00 per inch connection billed annually

For Each Fire Hydrant \$250.00 per year billed quarterly

4. Schedule D – Tapping Fees

Connection to Water System \$1,100.00 per EDU plus cost for time and materials for installation

Connection to Sewer System \$1,100.00 per EDU plus cost for time and materials for installation

Plus any other related fees including permit, engineering reimbursement fees.

5. Schedule E – Other Charges

Frozen Meter – current cost of replacement of meter plus call-out charge

10% Penalty if water bill is not paid by due date

Posting Delinquent Accounts \$20.00

Non-Payment Turn On/ Off – normal working hours \$50.00 after working hours \$150.00 or actual cost whichever is greater

Turn On/Off Fee per customer request \$50.00

Emergency Turn On/Off Fee N/C

Return Check / Non-Sufficient Funds \$30.00 (cash, money order or certified bank check required after 2nd consecutive NSF check) and certified letter fee and \$10.00 administrative fee + postage fees

Meter Test

5/8" – 3/4" \$25.00

1" \$50.00

Other Sizes at actual cost

If the meter tested is found to be accurate within the limits specified in PA Code 65.8 the fee will be retained, but if not so found the cost shall be borne by the Towanda Water System and the fee paid by the customer shall be refunded and billing adjusted.

Meter History Report \$25.00

Failure to schedule meter access \$150.00 a month until access is allowed

Lien Letter Fee \$40.00 plus other related costs

Certified Letter Fee \$10.00 plus other related costs

Attorney Fees & Filing Fees \$265.00
