Engineer:

Mr. Casanave stated there was a question at the last meeting about how much room was left in the system, water and sewer. Mr. Casanave presented a detailed summary of what he had researched. Mr. Casanave's assessment is that you are just about 60 percent what your allotment is with TMA. Mr. Casanave stated that would govern the day, because he is not seeing that's going to tell you any singular use is going to overload any one of your pumps immediately. Mr. Casanave stated he did not see any overbearing capacity problems, unless someone comes in and wants 70,000 gallons of and sewer use.

Mr. Casanave presented a retainer agreement to the board for Stiffler-McGraw.

Solicitor

Mr. Jones stated that we should have Mr. Casanave update the flows on EDU's. Mr. Jones also stated the rate changes if any should be discussed. Mr. Them stated that he delayed this so that he had a chance to do the budget if the accounting is done in time. Mr. Them stated if there were changes to be made, we could do them at any time.

Mr. Jones stated he had been contacted by the Bradford Towne Center representative. They are asking what the charges would be for the municipal authority to take over servicing and some sort of agreement that would be in place. Mr. Strickland stated his advisement would be not to take it over. Mr. Isaac questioned what the alternative to this would be. Mr. Strickland advised to hire an outside source. This is all their private system after the meter pit in the manhole. Every other place has a maintenance person, so it is not unprecedented. Mr. Williams stated his concern was the pump station. Mr. Strickland stated his advice is give them an hourly rate for what the pump station costs. The Board had a further discussion about the Bradford Town Center and the issues involved. Mr. Jones stated he would get with Mr. Strickland and get some rates and let her know we are not willing to service the entire process.

Mr. Jones presented an updated Solicitor Retention agreement.

Mr. Them made a motion to approve the raise and retention of Mr. Jones. Mr. Henson seconded.

Superintendents Report:

Mr. Strickland stated he was still working on the Grinder easements. Mr. Strickland also stated that he has been working on leaks.

Treasurers Report:

Mr. Them had some concerns over the accounting and discussed it with the Board. Mr. Them stated he would be addressing it with Ms. Schoonover.

Other Matters:

The Chairman recognized Mr. Lenox and Mrs. May as visitors. Mr. Lenox is here on behalf of Mrs. May. He would like the board to reconsider the determination of Mrs. May's March bill. Mrs. May stated her view points of the actions that had been taken in this matter. The board discussed many factors with Mrs. May and Mr. Lenox. Mr. Lenox argued that there should be more evidence. Mr. Lenox asked why the meter was changed. Mrs. May had requested that it be changed out.

Mr. Them asked that we change the day of week of the meetings to help everyone be able to make the meetings.

Mr. Isaac made a motion to adopt the amended meeting schedule for 2026 to the third Thursday at 9:30 am. Mr. Henson seconded.

Mr. Jones suggested we go into executive session to discuss Jeanette May.
